

Note 1: Let V_{th} be the voltage applied between gate and source that causes the drain current (I_D) to below (1 mA for this device). Then, for normal switching operation, $V_{GS(ON)}$ must be higher than V_{th} , and $V_{GS(OFF)}$ must be lower than V_{th} . This relationship can be expressed as: $V_{GS(OFF)} < V_{th} < V_{GS(ON)}$.






Fig. 5.3.1 Switching Time Test Circuit




Fig. 6.1 Marking




Fig. 7.1 I_D - V_{DS}




Fig. 7.3 $I_D - V_{GS}$




Fig. 7.5 $R_{DS(ON)}$ - V_{GS}




Fig. 7.2 I_D - V_{DS}




Fig. 7.4 $R_{DS(ON)}$ - V_{GS}




Fig. 7.6 R_{DS(ON)} - I_D




Fig. 7.7 R_{DS(ON)} - T_a




Fig. 7.9 |Y_{fs}| - I_D




Fig. 7.11 C - V_{DS}




Fig. 7.8 V_{th} - T_a




Fig. 7.10 I_{DR} - V_{DS}




Fig. 7.12 Dynamic Input Characteristics





Fig. 7.13 rth - tw







Fig. 7.15 Safe Operating Area
