1. General description

The 74HC3G16; 74HCT3G16 is a triple buffer. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{CC}.

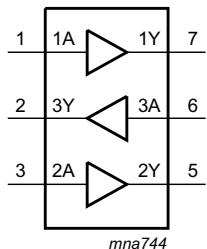


Fig 1. Logic symbol

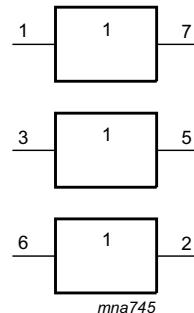


Fig 2. IEC logic symbol

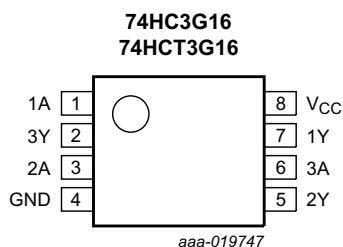


Fig 3. Pin configuration SOT505-2 (TSSOP8)

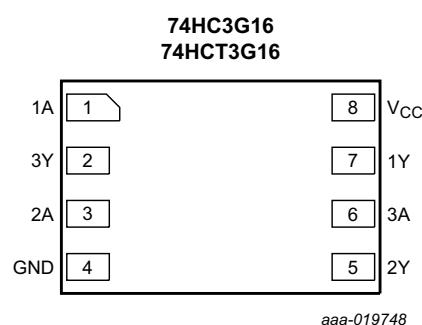


Fig 4. Pin configuration SOT996-2 (XSON8)

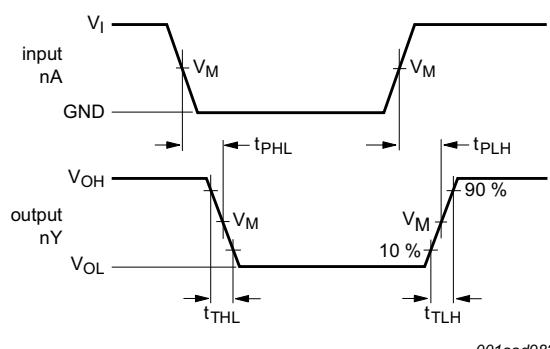

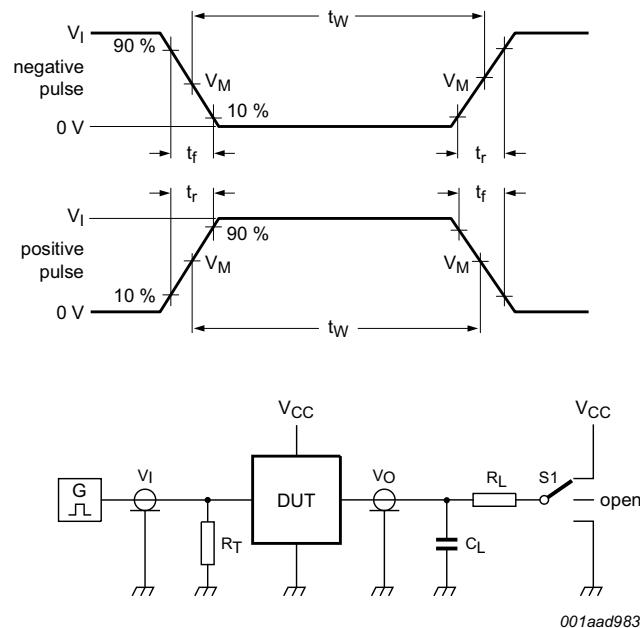

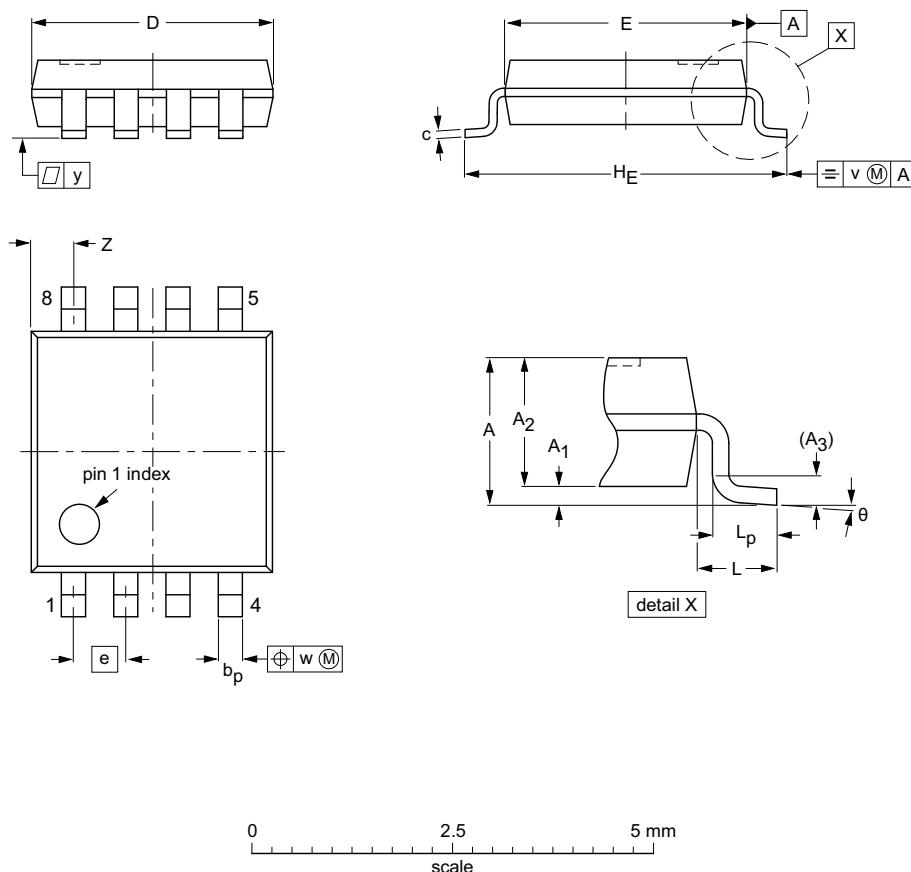
Fig 6. Test circuit for measuring switching times

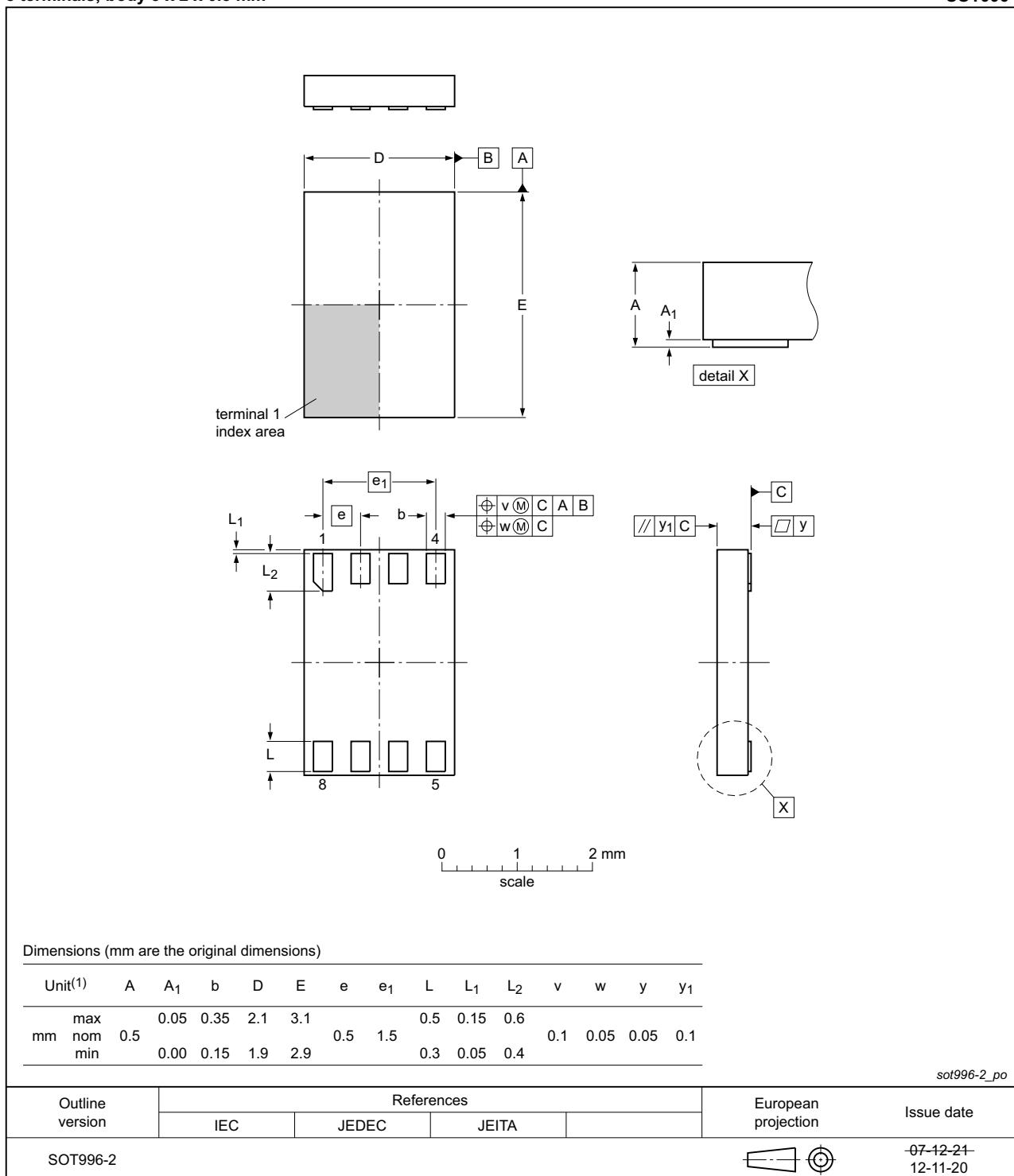


Fig 8. Package outline SOT996-2 (XSON8)
