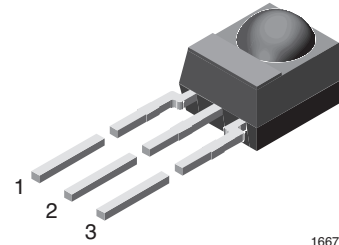


IR Receiver Modules for Remote Control Systems

Description

The TSOP49.. - series are miniaturized receivers for infrared remote control systems. PIN diode and preamplifier are assembled on lead frame, the epoxy package is designed as IR filter.

The demodulated output signal can directly be decoded by a microprocessor. The main benefit is the operation with a high envelope duty cycle datasignal and the good immunity against disturbance signals with spike characteristic as well as all continuous disturbance signals.

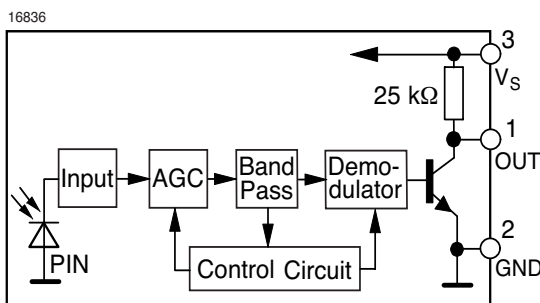

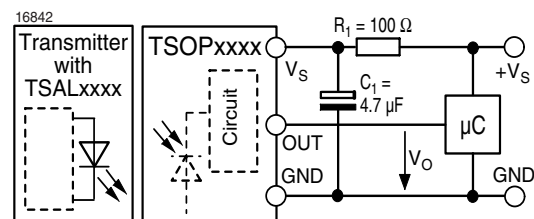

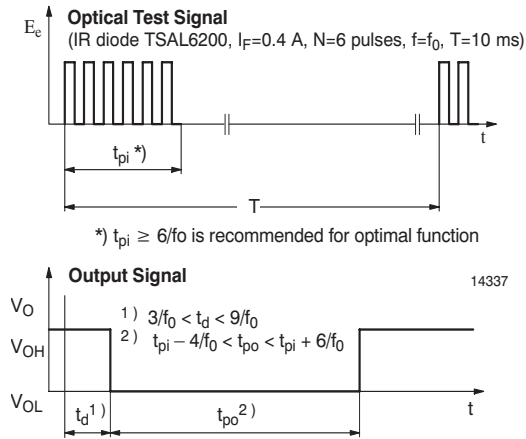


Figure 1. Output Function

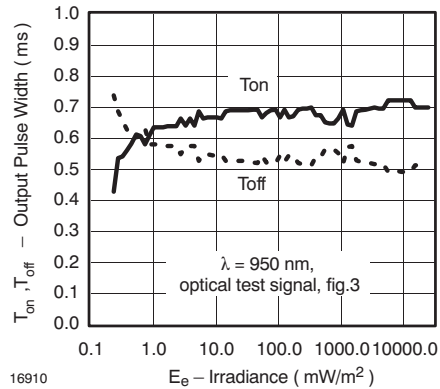


Figure 4. Output Pulse Diagram

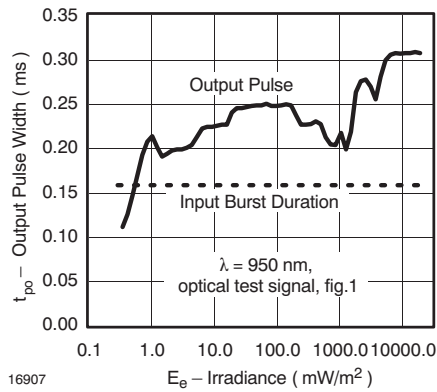


Figure 2. Pulse Length and Sensitivity in Dark Ambient

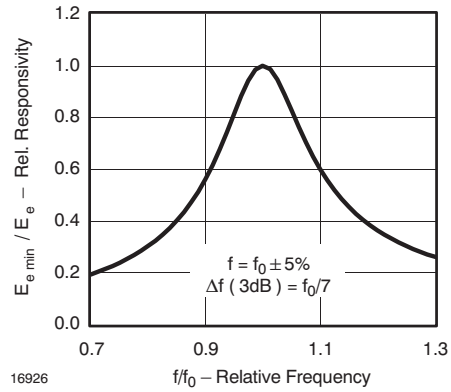


Figure 5. Frequency Dependence of Responsivity

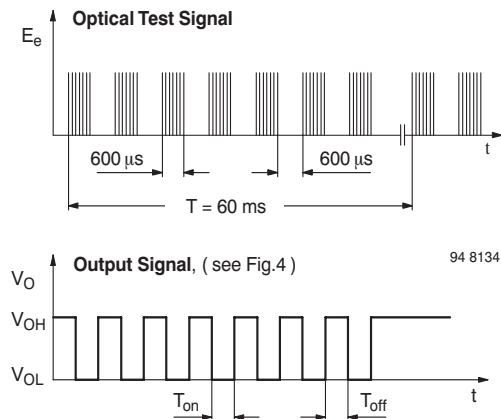


Figure 3. Output Function

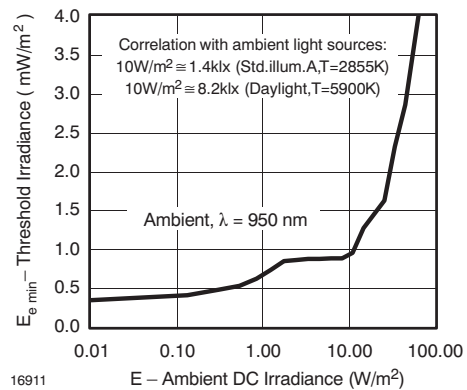
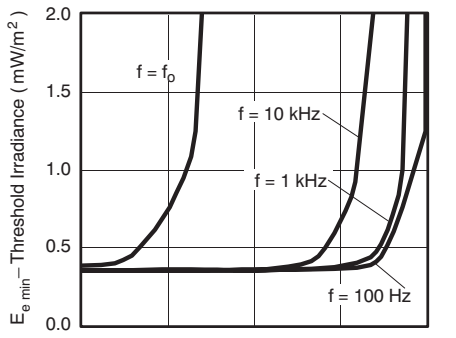
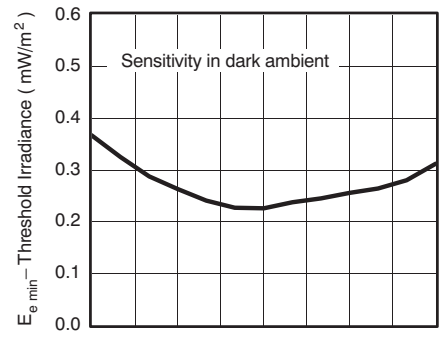


Figure 6. Sensitivity in Bright Ambient



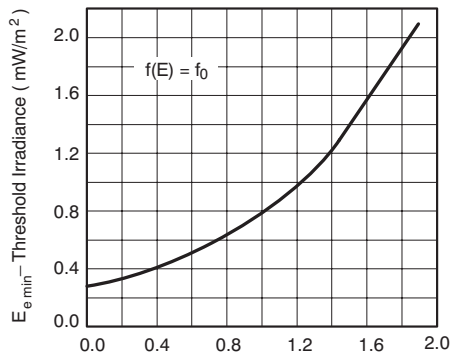
16912 $\Delta V_{S,RMS}$ - AC Voltage on DC Supply Voltage (mV)

Figure 7. Sensitivity vs. Supply Voltage Disturbances



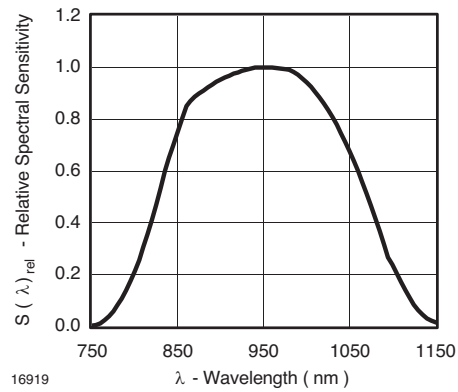
16918 T_{amb} - Ambient Temperature (°C)

Figure 10. Sensitivity vs. Ambient Temperature



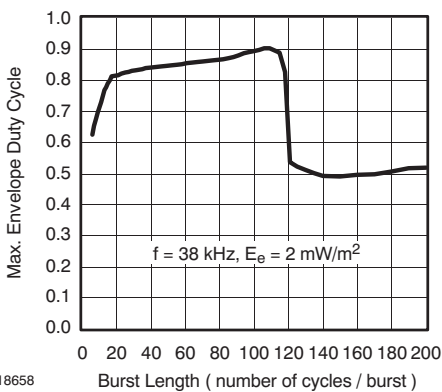
94 8147 E - Field Strength of Disturbance (kV/m)

Figure 8. Sensitivity vs. Electric Field Disturbances



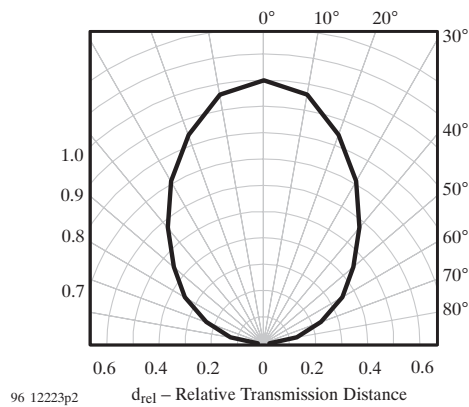

Suitable Data Format

The circuit of the TSOP49.. is designed in that way that unexpected output pulses due to noise or disturbance signals are avoided. A bandpass filter, a limiter stage, an integrator stage and an automatic gain control are used to suppress such disturbances.

The distinguishing mark between data signal and disturbance signal are carrier frequency, burst length and duty cycle.

The data signal should fulfill the following conditions:

- Carrier frequency should be close to center frequency of the bandpass (e.g. 38 kHz).
- Burst length should be 6 cycles/burst or longer.
- After each burst which is between 6 cycles and 120 cycles a gap time of at least 10 cycles is necessary.
- For each burst which is longer than 3.2 ms a corresponding gap time is necessary at some time in the data stream. This gap time should have at least same length as the burst.
- Up to 2200 short bursts per second can be received continuously.

Some examples for suitable data format are: NEC Code, Toshiba Micom Format, Sharp Code, RC5 Code, RC6 Code, RCMM Code, R-2000 Code, RECS-80 Code.

When a disturbance signal is applied to the TSOP49.. it can still receive the data signal. However the sensitivity is reduced to that level that no unexpected pulses will occur.

Some examples for such disturbance signals which are suppressed by the TSOP49.. are:

- DC light (e.g. from tungsten bulb or sunlight)
- Continuous signal at 38 kHz or at any other frequency

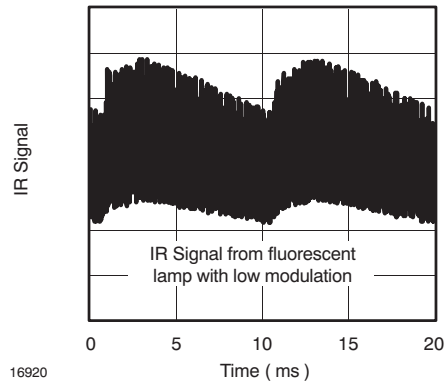


Figure 13. IR Signal from Fluorescent Lamp with low Modulation

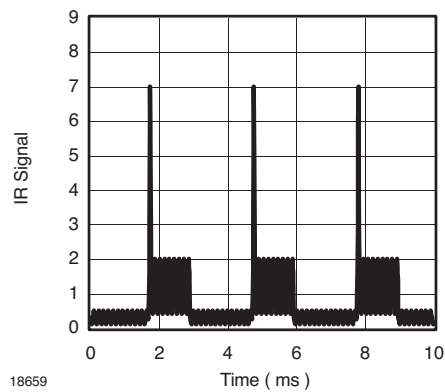
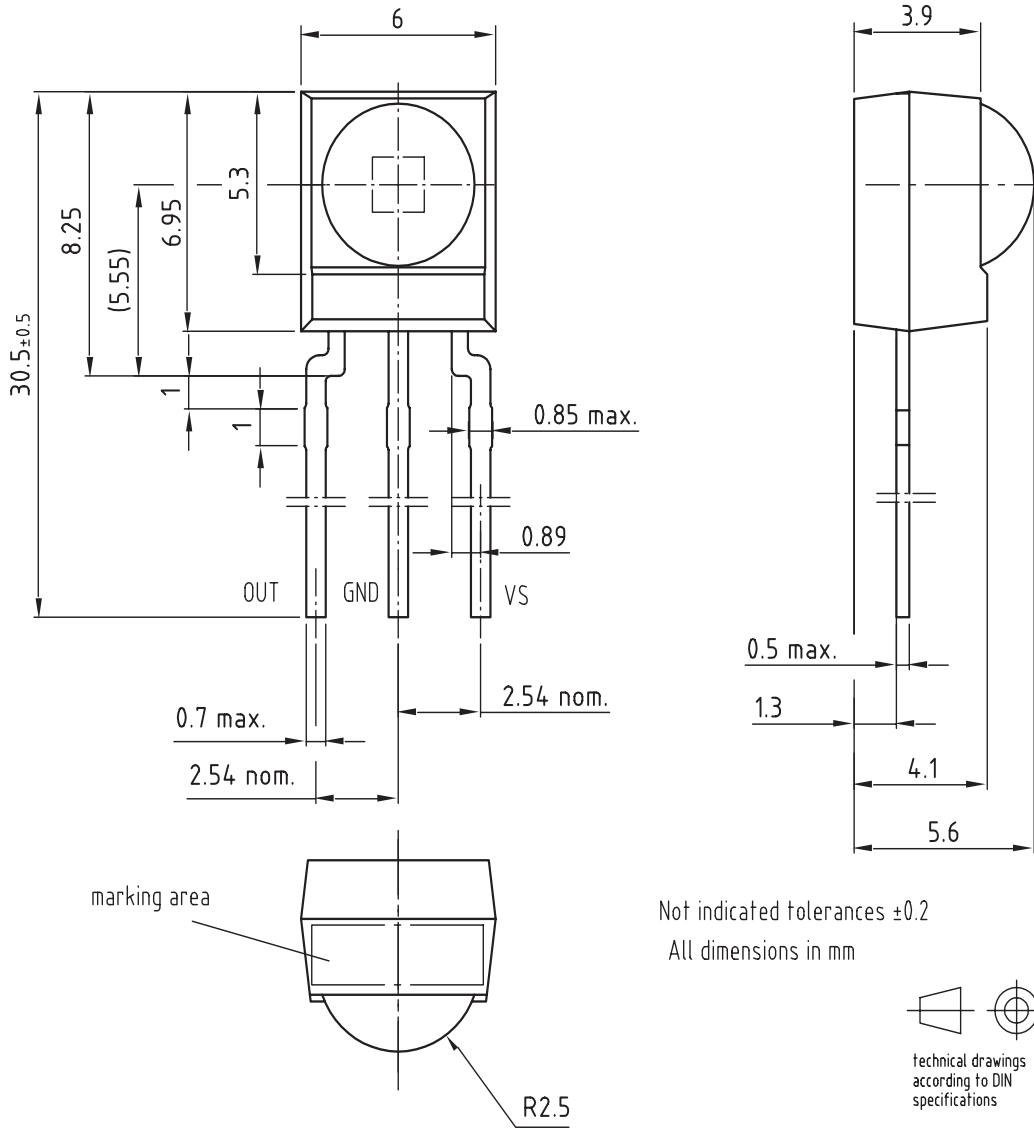


Figure 14. IR Signal from a Fluorescent Lamp with Spikes

- Signals from fluorescent lamps with electronic ballasts with various kinds of modulation (see examples in Figure 13 and Figure 14).
