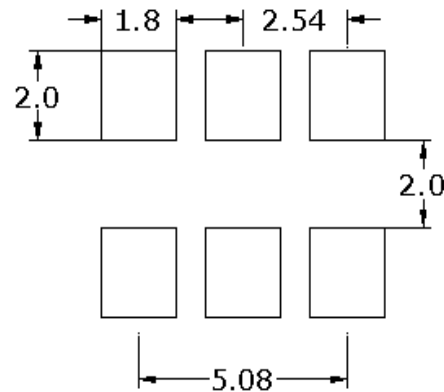

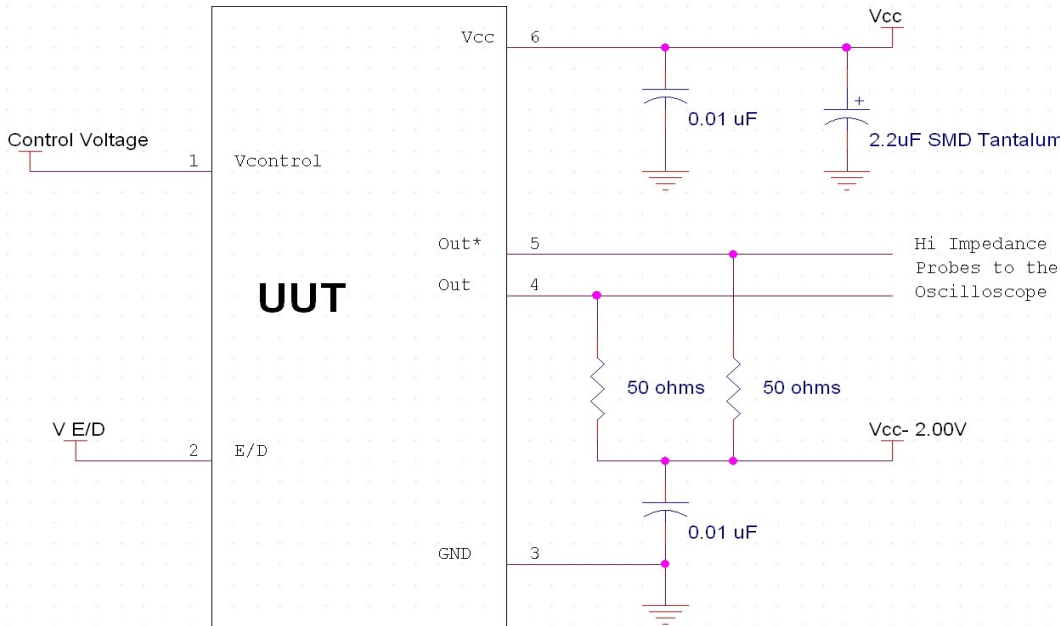
For Optimum Jitter Performance, Pletronics recommends:

- Do not place near piezoelectric buzzers or mechanical fans

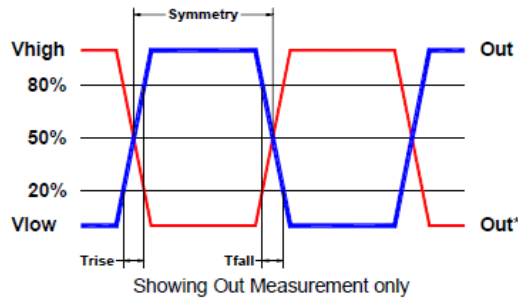

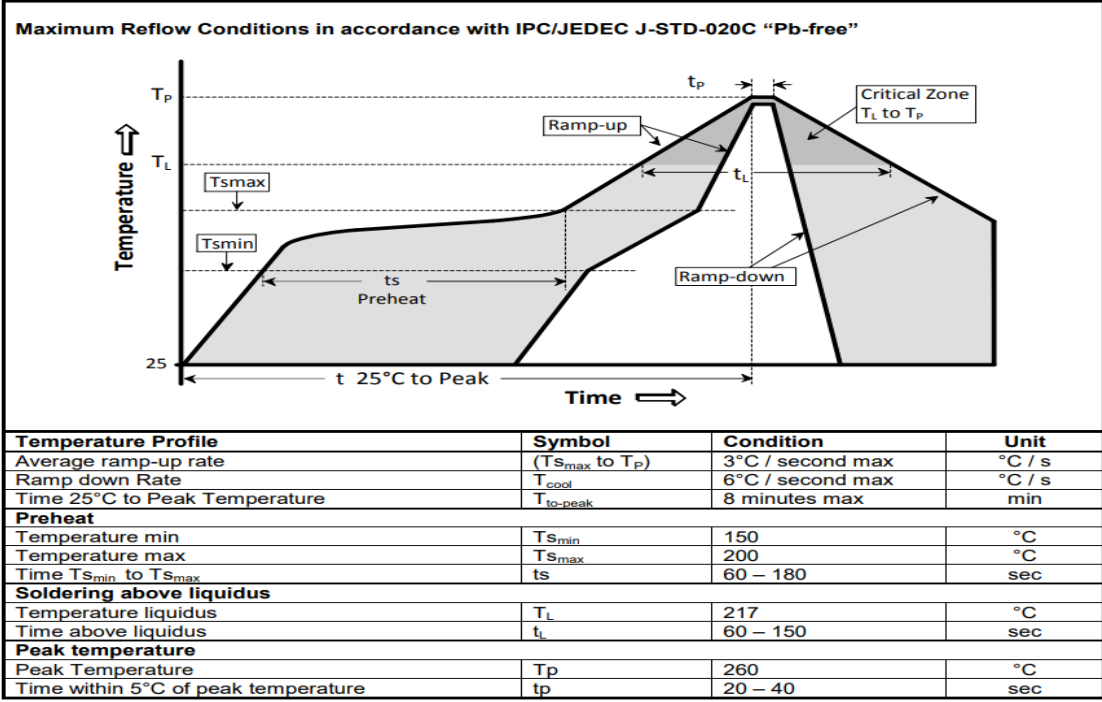

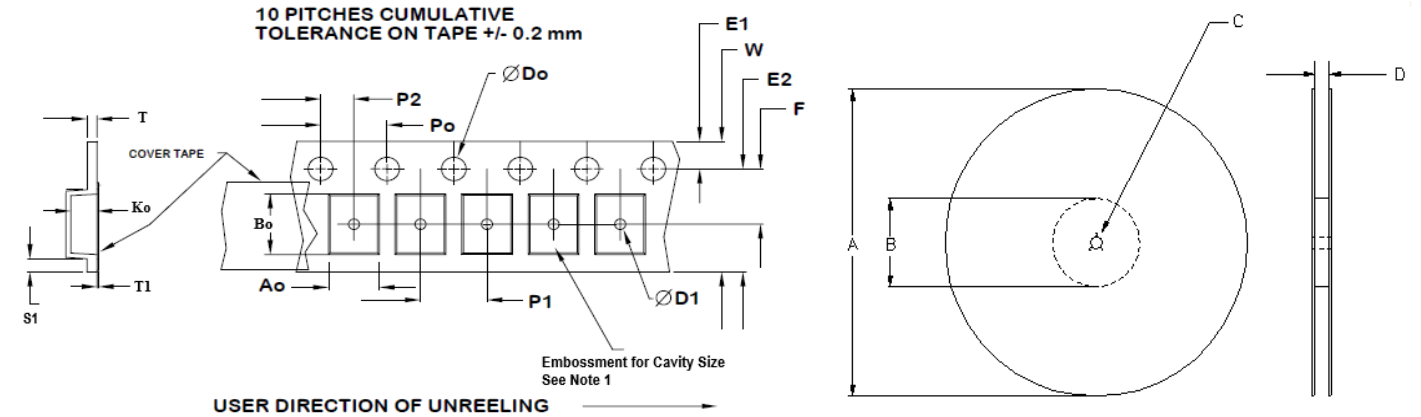
Reflow Cycle
